Subject: **2009 Street Fee Assessment**

Attached is the resolution to establish the 2009 fee assessment for the residential street light districts in the city at the same rate that Dekalb County assessed in 2008. Based on the final detailed census that we submitted to the Dekalb Tax Commissioner, the total 2009 Street Light Assessment is \$301,463.72 .

**A RESOLUTION PROVIDING FOR THE ASSESSMENT OF THE ANNUAL COST OF
MAINTAINING AND OPERATING STREET LIGHTS IN ESTABLISHED STREET
LIGHT DISTRICTS**

WHEREAS, Article IX, Section II, Paragraph 6, of the Constitution of the State of Georgia and Chapter 23 (Streets and Sidewalks) of the City Code of Ordinances authorizes and empowers the City Council of the City of Dunwoody, Georgia to establish districts for the purpose of building, erecting, establishing, maintaining, and operating street lights for the illumination of the public streets, roads, and sidewalks in the City of Dunwoody, and to levy a special assessment or tax against all property served by these functions; and

WHEREAS, DeKalb County, prior to the incorporation of the City of Dunwoody on December 1, 2008, had established Street Light Districts within the boundaries of the City; and

WHEREAS, on January 1, 2009, the City of Dunwoody took over responsibility for all the Street Lights and Street Light Districts within the boundaries of the City; and

WHEREAS, in the 2008 tax year, DeKalb County levied a special assessment or tax against all property served by the functions of the established Street Light Districts.
