# AN ORDINANCE OF THE CITY OF DUNWOODY AMENDING CHAPTER 27 (ZONING ORDINANCE) TO ALLOW FOR STAINLESS STEEL BIKE RACKS IN THE DUNWOODY VILLAGE OVERLAY DISTRICT

- **WHEREAS,** the City of Dunwoody is charged with providing for the health, safety and welfare of the citizens of the City; and
- **WHEREAS,** the City of Dunwoody Zoning Ordinance, codified as Chapter 27 of the City of Dunwoody Code of Ordinances, currently allows only dark green color bike racks in the Dunwoody Overlay District; and
- **WHEREAS,** the City Council desires to amend the bike rack provisions to allow for stainless steel bike racks that require less maintenance, in order to promote transportation alternatives in compliance with the City's dedication to sustainable living; and
- **WHEREAS,** the first read of this ordinance occurred on November 8, 2010 and a properly advertised public hearing and second read of this ordinance occurred on November 22, 2010.

# THEREFORE, THE MAYOR AND COUNCIL FOR THE CITY OF DUNWOODY HEREBY ORDAIN AS FOLLOWS:

<u>Section 1</u>: Chapter 27 (Zoning Ordinance) of the City of Dunwoody Code of Ordinances shall be amended by revising Article III (Ovelay District Regulation), Division 2 (Dunwoody Village Overlay District), Section 27-1273 to read as follows:
