## **MEMORANDUM**

**Subject:** Budget Ordinance for the Year Ending December 31, 2011

---

### **ITEM DESCRIPTION**

First read of the 2011 budget ordinance and discussion of adopting the budget for the fiscal year ending December 31, 2011.

### **BACKGROUND**

Georgia law (e.g., O.C.G.A. 36-81-2 et seq.), as well as the city's charter, provides the budget requirements for Dunwoody. The Mayor has presented Council a budget for discussion and adoption according to those requirements and budgetary policies adopted on September 28, 2009. Staff issued the initial draft of the Mayor's budget on August 31, 2010. A copy of the budget has been on display for public comment and review (both in hardcopy with the City Clerk as well as online.) Subsequently, the Mayor appointed three Council members to serve as a budget committee in order to review the document, make suggestions, and ask questions. On September 16<sup>th</sup>, the budget committee did meet as well as communicate several other times through phone conversations and e-mail exchanges. Also, staff reached out to all Council members to offer opportunities to discuss the budget and provide input. This document is the result of those numerous conversations that took place over the past four weeks.

### **ISSUES**

This proposed budget integrates all Council and budget committee comments throughout the review process. Highlights in the cover memo with supporting details are attached with following the ordinance.

Overall the budget presented here is balanced in that revenues meet or exceed expenditures. The budget reflects an anticipated surplus of \$1.3 million. Though it does not meet all desired levels of funding in all areas, staff feels the projected budget does represent a sustainable level of services that will meet or exceed most citizens' expectations. Also, it represents a diversified mix of priorities indicated from Council and citizens where each priority was addressed appropriately. The budget message preceding the budget details outline those priorities.

### **ALTERNATIVES**

Council may choose to propose an alternative budget.

### **RECOMMENDED ACTIONS**

It is respectfully requested that Council approve the ordinance adopting the proposed capital and operating budgets for the year ending December 31, 2011.

## ORDINANCE 2010-10-38

**AN ORDINANCE ADOPTING A BUDGET FOR THE FISCAL YEAR 2011 FOR EACH FUND OF THE CITY OF DUNWOODY, GEORGIA, PURSUANT TO ARTICLE V, SECTION 5 OF THE CHARTER OF THE CITY, BEGINNING JANUARY 1, 2011, AND ENDING DECEMBER 31, 2011, APPROPRIATING THE AMOUNTS SHOWN IN EACH BUDGET AS EXPENDITURES, ADOPTING THE ITEM OF ANTICIPATED FUNDING SOURCES, PROHIBITING EXPENDITURES TO EXCEED APPROPRIATIONS, AND PROHIBITING EXPENDITURES FROM EXCEEDING ACTUAL FUNDING SOURCES**

WHEREAS, a proposed budget for each of the various funds of the City has been presented to the Mayor and City Council; and

WHEREAS, appropriate advertised public hearings have been held on the proposed budget, as required by law and regulations; and

WHEREAS, the Fiscal Year 2011 Budget, and the Budget Message pursuant to Section 5.03(a) of the City Charter, have been filed in the office of the City Clerk and open for public inspection; and

WHEREAS, the Mayor and City Council have reviewed the proposed budget and have made certain amendments to both funding sources and appropriations; and

WHEREAS, each of the funds has a balanced budget, such that anticipated funding sources equal or exceed proposed expenditures; and

WHEREAS, the Mayor and City Council intend to adopt an annual budget for the Fiscal Year 2010:

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the City of Dunwoody, pursuant to their authority, as follows:

Section 1. That the City of Dunwoody, Georgia hereby adopts a budget for the Fiscal Year 2011, said budget being described below;

Section 2. That any increase or decrease in appropriations or revenue of any fund or for any department; the establishment of new capital projects; or the establishment of new grant projects other than those exceptions provided for herein, shall require approval of the City Council; and

Section 3. That this budget establishes a merit-based salary increases averaged 2.2% to all eligible full-time employees effective April 1, 2011 if they meet certain standards and are eligible for an additional bonus based on job performance as well as an optional vacation accrual exchange for up to 40 hours to all eligible full-time employees effective October 1, 2011; and

Section 4. That this budget fixes the number of established Dunwoody full-time positions at 58. This number may only be increased or decreased through approval of the Mayor and City Council; and

Section 5. That the City Manager and his/her designee may promulgate all necessary internal rules, regulations, and policies to ensure that this Budget Ordinance is followed.
