Subject: 2010 Resurfacing Contract Modification

ITEM DESCRIPTION

Approve amendment to contract for \$96,922.51 with Allied Paving for street resurfacing.

BACKGROUND

In June 2010, the Mayor and Council approved a unit price contract with Allied Paving for \$576,433.50 to resurface the streets shown in Attachment A. These streets were completed at a cost of \$540,479. Because these streets were completed under the contract limit and well within the available budget for paving, the alternate streets included in the bid document and listed on Attachment B were added to the contract at the same unit prices as the base bid. With the exception of Foxboro Lane, the additional streets also were completed within the budget estimate amounts.

Foxboro Lane was the last street paved and it became evident after work began on this street that the street had originally been constructed very poorly and would require complete reconstruction. More than half of the additional cost above the original contract amount can be attributed to the reconstruction of Foxboro Lane with the remaining increase attributed to the addition of the alternate streets to the contract.

FUNDING

There is funding remaining within the 2010 Capital Paving budget to cover the cost of this contract modification.

RECOMMENDED ACTION

I recommend approval of a contract amendment for \$96,922.51.
