Dear Mr. Hutmacher:

Please accept this correspondence in the form of a Letter of Understanding, to memorialize the discussions and consensus reached by the Dunwoody City Council on October 11, 2010. It is understood by both the City and CGA that the 2011 Professional Services Contract for Finance and Administrative Services will be amended as follows. The Marketing Manager position will be expanded from part time to full time with full benefits, at an annual fee increase of \$25,000. Additionally, the annual inflationary increase on the new base contract amount will equate to a 5% adjustment. The combined result of these current amendments for 2011 equates to an annual total contract fee of \$1,975,795. If any minor revisions to this calculation are identified subsequently, we anticipate no substantive change.
