ITEM DESCRIPTION

Award of Stonington Drive Storm Drain Replacement Project

BACKGROUND

This project is necessary to replace approximately 400 feet of deteriorated 24-inch, corrugated metal pipe (CMP), storm drain which passes across the front yards of 2470, 2478, 2486, and 2494 Stonington Drive. Due to the upland drainage area and to reduce the risk of potential flooding at 2494 Stonington Drive we are increasing the pipe size to a 36" HDPE Pipe.

FUNDING

This project can be funded from the \$120,000 capital reserve line item in the 2011 storm water utility budget. A bid evaluation and a copy of the bids are attached for your review.

RECOMMENDED ACTION

Staff respectfully requests that Council award the Stonington Drive Storm Drain Replacement Project to Blount Construction Company, Inc. for the amount of \$53,533.60 and authorize an additional 10% contingency for unforeseen field conditions.
