The original motion was voted and carried (5-2) with Council Members Bonser, Heneghan, Ross, Thompson and Wittenstein voting in favor of the ordinance, and Mayor Wright and Council Member Shortal voting against the ordinance.

SECOND READ: Ordinance to Amend Chapter 26, Streets, Sidewalks and Other Public Places re: Pole Banner Provisions for Special Events. (ORDINANCE 2011-01-02) (Mike Tuller)

Read by City Clerk Sharon Lowery. Mayor Wright motioned to approve the ordinance. Council Member Bonser seconded. The motion was voted and carried unanimously (7-0).

<u>SECOND READ: Ordinance to Amend Code of Ordinances to Add Chapter 25, Parks and Recreation.</u> (ORDINANCE 2011-01-03) (Brent Walker)

Read by City Clerk Sharon Lowery. Mayor Wright motioned to approve the ordinance. Council Member Ross seconded. The motion was voted and carried unanimously (7-0).

SECOND READ: Ordinance to Amend Chapter 6, Animals re: Animal Control. (ORDINANCE 2011-01-05) (Warren Hutmacher)

Read by City Clerk Sharon Lowery. Council Member Shortal motioned to approve the ordinance. Council Member Thompson seconded. Council Member Heneghan motioned to amend Section 6.9 regarding DeKalb County owner's permit, to remove from the first sentence the words "the DeKalb County owner's permit and," and to remove the following words from the next sentence after the word "collar:" "together with the permit and tag." Mayor Wright seconded for purposes of discussion. The amended motion was voted and failed (0-7). The original motion was voted and carried unanimously (7-0).

NEW BUSINESS:

FIRST READ: Ordinance to Amend Chapter 26: Streets, Sidewalks and Other Public Places re: Recycling at Special Events. (ORDINANCE 2011-02-XX) (Mike Tuller)

This item was moved to item L2. Read by City Clerk Sharon Lowery. Presented by Community Development Director Mike Tuller. This item will be a Second Read at the first voting meeting in February, 2011.

Resolution Authorizing Zip Code Change Request of United States Postal Service. (RESOLUTION 2011-01-01) (Kimberly Greer)

This item was moved to item L3. Read by City Clerk Sharon Lowery. Council Member Wittenstein motioned to approve the resolution. Council Member Heneghan seconded. The motion was voted and carried unanimously (7-0).

Award of Contract for Consulting Services for Vendor Selection Process. (Warren Hutmacher)

This item was moved to item L4. Presented by City Manager Warren Hutmacher. City Manager Hutmacher said that the City received four bids in response to the request for proposal, which ranged from \$25,000.00 to \$64,800.00. Mr. Hutmacher recommended that Council approve the contract award for either Hill International, Inc. in the amount of \$22,500.00 or Rahim, Inc. d/b/a RNR Consulting "RNR" in the amount of \$45,360.00; he explained that RNR would be able to provide industry knowledge and experience that Hill International, Inc. would not be able to provide. Council Member Wittenstein motioned to authorize the City Manager to execute a contract with RNR in an amount up to \$45,360.00. Mayor Wright seconded. The motion was voted and carried (5-2), with Mayor Wright and Council Members Bonser, Heneghan, Thompson and Wittenstein voting in favor of the motion, and Council Members Ross and Shortal voting against the motion.

Resolution to the DeKalb County School System Supporting the General Concepts of Allowing Current Dunwoody Cluster Students to Remain in the Dunwoody Cluster and Supporting the Availability of Magnet Programs Throughout the County. RESOLUTION 2011-01-02) (Robert Wittenstein)

This item was moved to item L1. Read by City Clerk Sharon Lowery. Council Member Wittenstein motioned to approve the resolution. Council Member Thompson seconded. Council

Member Wittenstein motioned to amend the resolution as follows: to remove the following words in the title of the resolution: "AND SUPPORTING THE AVAILABILITY OF MAGNET PROGRAMS THROUGHOUT THE COUNTY;" to remove the fourth "Whereas" paragraph from the resolution which states as follows: "WHEREAS, Mayor and City Council of Dunwoody recognize the importance of maintaining the magnet program at the current school locations; and"; and to remove Section 2 from the resolution as follows: "Section 2: Establish a redistricting plan for the Dunwoody Cluster which keeps the Kittredge/Chamblee Middle School/Chamblee High School magnet program at current school locations; and." Council Member Thompson seconded.

Mayor Wright opened public comment without objection.

Mayor Wright asked those wishing to speak in favor of the resolution amendment to come to the podium.

Page Olson – voiced concern regarding Hightower Elementary School that feeds into the Dunwoody cluster.

Mayor Wright asked those wishing to speak in opposition to the resolution amendment to come to the podium.

Renate Herod – voiced concern regarding the resolution.

Mayor Wright closed public comment without objection.

Council voted to amend the resolution as stated, and the vote carried unanimously (7-0).

The amended resolution was voted on and carried unanimously (7-0).

Resolution Adopting and Approving Regulatory Fees for Massage Establishment Licenses and Permits. (RESOLUTION 2011-01-03) (Lenny Felgin)

Read by City Clerk Sharon Lowery. Council Member Shortal motioned to approve the resolution. Council Member Wittenstein seconded. The motion was voted and carried unanimously (7-0).
