**Subject:** Special Event Signage for Save Our Skin 5K

## **ITEM DESCRIPTION**

The event coordinator for the Save Our Skin 5K, occurring on June 25, 2011, has made application to the City for signs larger than the size restrictions of the ordinance to be placed at Perimeter Place Shopping Center, 100 Perimeter Center Place, NE. Per the terms of Chapter 26, Section 26-275, the applicant is required to receive approval from Mayor and City Council to erect the additional signs. The attached application and spreadsheet describe the requested signs and indicate which types of signs are permitted by right, which are recommended based on the administrative guidelines, and which are not permitted according to any provision. The reason each type is not allowed per the specified document is identified in the subsequent column. The N/A designation notes that the sign complies with the requirements of either the Ordinance or Administrative Guidelines.

## **RECOMMENDED ACTION**

Staff recommends approval based on the administrative guidelines. All the signs comply with the administrative guidelines except the "FINISH" banners.
