BACKGROUND

This amendment to the recently approved LMIG contract with the Georgia Department of Transportation (GDOT) changes the specified mixes for reimbursement. The City requested the changes to the asphalt mix due to concern that the originally specified mixes would not provide a suitable overlay based on the condition of the streets being paved. The total contract amount is reduced by \$9.78.


