

**A RESOLUTION TO APPOINT NEW MEMBERS FOR THE SUSTAINABILITY  
COMMISSION FOR THE CITY OF DUNWOODY, GEORGIA**

**WHEREAS,** the City of Dunwoody is authorized by the City Charter to create boards, commissions and authorities as the Mayor and City Council deem necessary; and

**WHEREAS,** Resolution 2008-12-31 created the Sustainability Commission for the City of Dunwoody, GA; and

**WHEREAS,** the Sustainability Commission continues to pursue certification by the Atlanta Regional Commission under their Green Communities program; and

**WHEREAS,** Resolution 2009-10-56 established terms for each member of the Sustainability Commission; and

**WHEREAS,** Debbie Gordon and David Southerland were previously appointed as members of the Sustainability Commission to a two-year term, expiring December 31, 2011; and

**WHEREAS,** City Council wishes to appoint Debbie Gordon and David Southerland as members of the Sustainability Commission for a term as follows:

Debbie Gordon, 2 year term .....expiring December 31, 2013  
David Southerland, 2 year term .....expiring December 31, 2013  
and,

**WHEREAS,** Elizabeth Hudson, Connie Morelle, Joe Seconder, and Bobbi Sedam were previously appointed as members of the Sustainability Commission to a three-year term, expiring December 31, 2011; and

**WHEREAS,** City Council wishes to appoint Connie Morelle, Lee Patterson, Joe Seconder, and Bobbi Sedam as members of the Sustainability Commission to four-year term as follows:

Connie Morelle, 4 year term .....expiring December 31, 2015  
Lee Patterson, 4 year term .....expiring December 31, 2015  
Joe Seconder, 4 year term .....expiring December 31, 2015  
Bobbi Sedam, 4 year term.....expiring December 31, 2015  
and,

**WHEREAS,** Su Ellis and Linda Shulin were previously appointed as members of the Sustainability Commission to a two-year term, expiring December 31, 2012; and

**WHEREAS,** the positions occupied by Su Ellis and Linda Shulin as members of the Sustainability Commission have become vacant, prior to the expiration of the terms, and the City Council wishes to fill said vacancies by

appointing Iris Callaway and Keith Dyché as members of the Sustainability Commission for the remainder of said terms as follows:

Iris Callaway, 2 year term .....expiring December 31, 2012  
Keith Dyché, 2 year term .....expiring December 31, 2012  
and,

**WHEREAS,** this Resolution shall become effective upon its adoption.

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the City of Dunwoody while in regular session on March 26, 2012 at 7:00 pm, that Iris Callaway, Keith Dyché, Debbie Gordon, Connie Morelle, Lee Peterson, Joe Seconder, Bobbi Sedam, and David Southerland are appointed as members of the Sustainability Commission for the designated terms as stated above.
