Subject: **Discussion of 2013 Planning and Zoning Meeting Schedule.
(Steve Dush)**

ITEM DESCRIPTION

Staff has prepared a schedule for Mayor and Council Review that coordinates the three following meeting tracks for 2013: Planning and Zoning, Mayor and Council, and Zoning Board of Appeals.

BACKGROUND

Pursuant to the city Zoning Ordinance, §27-1431. "Filing of Applications," the annual schedule for actions to be heard in front of the Dunwoody Planning Commission must be prepared by the Planning Department and subsequently approved by the Mayor & Council.

The text of the Zoning Ordinance reads, in part:

"(a) All applications for amendments to the comprehensive plan land use maps and the official zoning map shall be filed with the director of planning on forms provided by the department of planning. The processing of said applications shall be based upon an annual schedule prepared by the department of planning and adopted by the City Council..."

RECOMMENDED ACTION

The schedule prepared for 2013 is comparable to the dates and deadlines from the 2012 schedule. Staff requests that the attached annual schedule be approved in accordance with the above ordinance.
