THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

ON 02-07-13 AT 0802 HOURS I, OFC. EHLBECK RESPONDED TO CHESNUT ELEMENTARY SCHOOL REGARDING A PERSON ALMOST STRUCK BY A VEHICLE. I MET WITH JOHN HENEGHAN THE REPORTING PARTY. MR. HENEGHAN STATED THAT HE WAS CONTACTED BY THE SCHOOL PRINCIPAL TO INFORM THAT HIS 7 YEAR OLD SON DECLAN WAS ALMOST STRUCK BY A VEHICLE AS HE WAS CROSSING N PEACHTREE ROAD IN THE SCHOOL CROSS WALK. HE SAID DECLAN WAS PULLED TO SAFETY BY SCHOOL CROSSING GUARD, LORRAINE KNOX SO HIS SON WAS NOT STRUCK BY THE VEHICLE.

MS. KNOX STATED THAT AT 0725 HOURS ON THIS DATE SHE WAS WORKING THE CROSS WALK IN FRONT OF CHESNUT AND AS STUDENTS APPROACHED THE CROSS WALK ON THE EAST SIDE OF N PEACHTREE SHE ENTERED THE ROADWAY, HELD UP HER DOUBLE SIDED FLASHING STOP SIGN TO STOP TRAFFIC SO THE STUDENTS COULD CROSS. SHE SAID THE NORTHBOUND TRAFFIC STOPPED AND THERE WAS NO SOUTHBOUND TRAFFIC SO SHE TOLD THE STUDENTS TO CROSS. MS. KNOX SAID SHE SAW A PICK UP TRUCK TRAVELING SOUTH ON N PEACHTREE ROAD APPROACHING THE CROSS WALK. MS. KNOX SAID SHE SAW THE PICK UP TRUCK WAS NOT GOING TO STOP AND PULLED DECLAN OUT OF THE WAY JUST BEFORE THE PICK UP TRUCK STRUCK HIM. THE PICK UP TRUCK DID NOT STOP AND RAN OVER DECLAN'S ROLLING BOOK BAG. THE TRUCK DRIVER STOPPED AND PULLED OVER TO THE CAR POOL LANE ON N PEACHTREE ROAD IN FRONT OF THE SCHOOL.

MS. KNOX SAID SHE MADE SURE DECLAN WAS NOT INJURED AND SHE AND THE DRIVER, HENRY SKELTON ESCORTED DECLAN TO THE FRONT OFFICE. MR. SKELTON PROVIDED A COPY OF HIS DRIVER'S LICENSE AND PHONE NUMBER TO MS. KNOX AND LEFT THE SCHOOL. MS. KNOX SAID SHE CONTACTED HER SUPERVISOR S.R.O. SMITH AND ADVISED HIM OF THE INCIDENT. UPON THE ARRIVAL OF MR. HENEGHAN AT THE SCHOOL HE CONTACTED THE DUNWOODY POLICE DEPARTMENT.

A WRITTEN STATEMENT OF THE INCIDENT WAS TAKEN FROM MS. KNOX AND ATTACHED TO THIS REPORT ALONG WITH PHOTOGRAPHS OF DECLAN'S DAMAGED BOOK BAG.
