**A RESOLUTION TO APPOINT MEMBERS OF THE BOARD OF ETHICS FOR THE CITY
OF DUNWOODY, GEORGIA**

WHEREAS, the City of Dunwoody is authorized by the City Charter to create boards, commissions and authorities as the Mayor and City Council deem necessary; and

WHEREAS, the Mayor and City Council previously adopted Chapter 2 ("Administration") of the City Code of Ordinances which calls for the creation of the Board of Ethics; and

WHEREAS, the Mayor and City Council amended Article VIII ("Ethics") of Chapter 2 of the City Code of Ordinances which calls for the appointment of two alternate members of the Board of Ethics; and

WHEREAS, the Board of Ethics shall serve as a hearing body of the City pursuant to the terms of Article VIII of Chapter 2 of the City of Dunwoody Code of Ordinances and shall serve to implement its function in accordance with the City of Dunwoody Code; and

WHEREAS, Janet Webb and Wade Wright were previously appointed as members of the Board of Ethics to a three year term, expiring on January 26, 2013.

WHEREAS, City Council wishes to appoint Janet Webb and Wade Wright as members of the Board of Ethics for a term as follows:

Janet Webb, 3 year termexpiring January 26, 2016
Wade Wright, 3 year termexpiring January 26, 2016

WHEREAS, City Council wishes to appoint Taylor Harper and Joanie Dwoskin as alternate members of the Board of Ethics for a term as follows:

Kevin Bahr, 3 year termexpiring January 26, 2016
Taylor Harper, 3 year termexpiring January 26, 2016

WHEREAS, this Resolution shall become effective upon its adoption.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Dunwoody while in regular session on May 28, 2013 at 7:00 pm, that Janet Webb and Wade Wright are appointed as members of the Board of Ethics for the designated terms as stated above.
