**A RESOLUTION TO APPOINT A MEMBER OF THE ALCOHOL LICENSE REVIEW

WHEREAS, the Mayor and City Council previously adopted Chapter 2 ("Administration") of the City Code of Ordinances which calls for the creation of the Alcohol License Review Board; and

WHEREAS, Resolution 2009-06-38 created the Alcohol License Review Board for the City of Dunwoody, GA. with five members; and

WHEREAS, the position held by former board member Michael Bryan has become vacant prior to the expiration of the term; and

WHEREAS, the Mayor of the City of Dunwoody is authorized with confirmation from the City Council to appoint Jim Roberts to the Alcohol License Review Board for the City of Dunwoody, and to add the following term of office:

Jim Roberts, 3 year term..... expiring June 30, 2020

WHEREAS, this Resolution shall become effective upon its adoption.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Dunwoody while in regular session on July 24, 2017 at 6:00 p.m. that Jim Roberts is appointed as a member of the Alcohol License Review Board for the designated term.
