Subject: Dunwoody Nature Center Detention Facility and Micropool Funding Request

## ITEM DESCRIPTION

Approval of funding for the installation of a stormwater detention facility and micropool at the Dunwoody Nature Center.

## BACKGROUND


The main building of the Dunwoody Nature Center is located downstream of numerous adjoining properties. Runoff from several of these properties collect in a drainage ditch located north of the Dunwoody Nature Center Driveway. This ditch flows east towards Wild Cat Creek along the north side of the main building at the Nature Center. As currently configured, the Dunwoody Nature Center's trails, outbuildings and program areas are negatively affected by erosion, debris accumulation and potential flooding from this drainage. In addition, the construction of the Nature Center Pavilion will also increase the impervious area in this basin, resulting in a small increase in stormwater flows to these areas.

The proposed extended detention and micropool facility will address the current problem, alleviate any additional impacts from the construction of the Nature Center Pavilion and provide a water quality benefit. Micropools have a moderate to high rate of urban pollutant removal, are highly accepted in public areas and introduce opportunities for wildlife.


# **RECOMMENDED ACTION**

Staff recommends approving funding for the construction of an extended detention facility and micropool in an amount of \$215,417.40, which includes a 10% contingency.
