Subject: Approval of Contract with GC&E Systems Group for Video Surveillance

Cameras at Pernoshal Park and Georgetown Park

DESCRIPTION

Approval of a contract with GC&E Systems Group for the installation and maintenance of a Video Surveillance System at both Pernoshal Park, Georgetown Park and a portion of the trail system entering Brook Run Park from Pernoshal Park.

BACKGROUND

The City of Dunwoody currently has video surveillance cameras located in Brook Run Park and City Hall. These cameras are maintained on our Genetec platform, which now includes all building access controls as well.

GC&E Systems Group currently provides both annual support and maintenance under a contract for both the video surveillance systems, License Plate Reader cameras and the access control systems. GC&E provides 24/7/365 service within one hour with a four hour onsite response time.

In 2016, the Council appropriated \$271,000 for the installation of video surveillance cameras and License Plate Reader cameras at Pernoshal Park, Georgetown Park and portions of the trail at Brook Run Park.

GC&E Systems Group has provided a quote of \$286,137.51 for the installation of video cameras and LPRs in Pernoshal Park, video cameras in Georgetown Park and a portion of the trail system in Brook Run Park.

RECOMMENDATION

At this time, staff recommends the City Council approve the contract with GC&E Systems Group for \$286,137.51 as a Single Source purchase.

The City of Dunwoody Purchasing Policy reads as follows:

"The City may acquire Goods and Service pursuit to a **Single Source** Procurement. A Single Source Procurement is a procurement made from one Person among others in a competitive market place which, for justifiable reasons, is found to be most advantageous for the purpose of fulfilling the given purchasing need. The User must provide the justification for the Single Source Procurement to the Purchasing Agent after approved by the City Manager or Council. The Purchasing Agent may elect to purchase particular brand name Goods or Services when the Goods or Services comprise a major brand system, program or service previously selected by the City and due to operational effectiveness, future enhancements or additions, or maintenance or storage of spare parts precludes the mixing of brands, manufacture, etc."

Single Source Procurement is permissible by the City of Dunwoody policy. Staff believes using this method and awarding the contract to GC&E Systems Group is appropriate due to several important reasons:

- GC&E Systems Group is the current vendor we use to support our video surveillance cameras, LPRs and access control system.
- Having the same vendor handle the installation of the cameras as well as the support provides a seamless project and eliminates any finger pointing if something doesn't work after installation.
- GC&E Systems Group is already familiar with our current systems and operations

I have worked closely with Ashley Smith and Brent Walker on this project. Both concur with the Single Source purchase contract as does our Purchasing Department.

Additional funds of \$15,137.51 to cover the difference between the allocated funds and the contract price will come from previous allocated Capital funds that were left over from a previous License Plate Reader project.

1.0 Introduction: Company Background and Experience

2.0 Scope of Work

2.1 Solution Summary

This proposal is for the installation of a new IP video management system for the City of Dunwoody Parks and Recreation's Pernoshal and Georgetown Parks. This proposal includes the installation of eleven (11) new 20' steel camera poles, weatherproof enclosures, and twenty (20) IP cameras (combination of fixed and 180° IP cameras). The pole and cabling for a future LPR camera is provided at the Pernoshal Park entrance. All required conduits, pole grounds, camera power and fiber cabling is

included. This CCTV system will provide both deterrent and detection capability, enhancing the safety of all visitors to the park.

2.2 Installation Approach

Head End Equipment Pernoshal Park Pavilion

This project consists of one (1) NetGear switch, and one (1) fiber optic enclosure mounted in the existing customer network rack located in the network closet in the Pernoshal pavilion. There will be a network connection available by the customer in the main pavilion for the newly installed switch with connectivity to the City of Dunwoody City Hall Genetec server. The customer will need to provide IP addresses for all IP cameras, and server prior to installation. Included with this proposal are (20) Genetec camera licenses, and twenty (20) Genetec Advantage for 1-year SMA's.

Pole locations and Equipment for Pernoshal Park Trail to Brook Run Trail

This project consists of the installation of five (5) new 20' metal poles throughout the Pernoshal Park Trail to maintain line of site along the trail to the beginning of the Brook Run Park Trail parking lot. Each of these poles will be installed with new concrete bases, and associated grounding materials. New OSP fiber optic cabling, and 120VAC electrical cabling from the main pavilion to each pole will be installed to provide communications, and power at each pole. Each pole will receive one (1) L-com weather proof enclosure with a 120V outlet, one (1) Interlogix hardened POE switch, and one (1) fiber optic enclosure with a fiber adapter panel. The two (2) of the poles located from the main Pernoshal trail to the beginning of Brook Run trail parking lot will each receive one (1) Axis P3225-VE MkII IP dome camera. Then three (3) poles will each receive one (1) Axis Q3708-PVE 180° IP dome



camera to view the paths in each direction of the poles location. Each of the camera locations are depicted in the drawings below. These newly installed IP cameras will each receive a Ditek surge suppressor that will be bonded to a local ground point. New Category 6 OSP shielded cable will be installed for each new pole IP camera. Upon completion of the installation GC&E will aim, and focus the cameras for proper viewing with the customer.

Pole locations and Equipment for Pernoshal Park Amphitheater and Pavilion

This project consists of the installation of six (6) new 20' metal poles throughout the Pernoshal Park as depicted on the attached drawing. Each of these poles will be installed with new concrete bases, and associated grounding materials. New OSP fiber optic cabling, and 120VAC electrical cabling from the main pavilion to each pole will be installed to provide communications, and power at each pole. Each pole will receive one (1) L-com weather proof enclosure with a 120V outlet, one (1) Interlogix hardened POE switch, and one (1) fiber optic enclosure with a fiber adapter panel. There will be a total of four (4) Axis Q3708-PVE 180° IP cameras, three (3) Axis P3225-VE fixed IP cameras, and one (1) LPR IP camera. The cabling and materials for the LPR camera will be installed on the pole at the main entrance to the park. These newly installed IP cameras will each receive a Ditek surge suppressor that will be bonded to a local ground point. New Category 6 OSP shielded cable will be installed for each new pole IP camera. Upon completion of the installation GC&E will IP address, aim, and focus the newly installed IP cameras with the customer.

- *** Existing conduit around Pernoshal Park Amphitheater trail to Georgetown crosswalk is in place, free, and clear of all obstructions ***

Camera locations and Equipment for Georgetown Park Georgetown East Pavilion

The Georgetown East pavilion will receive one (1) NetGear POE switch in the existing network rack, and three (3) Axis P3225-VE IP cameras in the following locations: one (1) with a view of the restroom, one (1) with a view of the pavilion, and one (1) looking at the sidewalk and street area. There will be one (1) Axis Q3708-PVE installed above the pavilion with a view towards the main center area. New Category 6 OSP shielded cable will be installed from the pole to the newly installed NetGear switch in the network closest. There will be a network connection available by the customer in the electrical room at the East Pavilion with connectivity to the City of Dunwoody network. Upon completion of the installation GC&E will IP address, aim, and focus the newly installed IP cameras with the customer. The (20) Genetec IP camera licenses, and (20) Genetec Advantage for 1-year SMA's are part of this scope of work.

Georgetown West Pavilion

The Georgetown West pavilion will receive one (1) NetGear POE switch in the existing network rack, and four (4) Axis P3225-VE IP cameras in the following locations: two (2) on the front of the pavilion with a cross view of the entrance into the park, and one (1) on the back looking into the park area. New Category 6 cable will be installed from each camera and terminated to the new NetGear POE switch. Each of these new IP cameras will receive one (1) new Ditek surge suppressor that will be bonded to a local ground. There will be a network connection available by the customer in the electrical room at the West pavilion with connectivity to the City of Dunwoody network. Upon completion of the installation GC&E will IP address, aim, and focus the newly installed IP cameras with the customer.

3.0 Warranty

Upon substantial completion of the project, GC&E provides a one (1) year warranty on parts and labor.

To receive product replacement and or warranty support, the customer is required to comply with the manufacturer's standard product registration process as well the standard product return policy that may include prior contact with manufacturer Technical Support, returning defective materials in the original packaging along with all original connectors, cable assemblies, connectors, and all original documentation.

Warranty Coverage does not include damage or malfunction due to accident, acts of nature (including lightning strikes), improper operation, power surge/loss, misuse, neglect, unauthorized modification or repair or use in a manner for which the equipment was not intended. Nor does it cover technician services for troubleshooting, removing or replacing any failed component not covered by this warranty.



4.0 Exclusions or Items Not Included in Quote

- Repairing any pre-existing issues with the system associated with the installation
- Bid, payment, or performance bond costs
- Troubleshooting of existing network, power, or grounding issues
- Correcting of existing code violations
- Network connection to City of Dunwoody network
- Genetec server, and video storage

5.0 General Assumptions and Clarifications

- 120V electrical power is available on site to power new equipment
- Pricing is contingent on the project being award as a whole
- Rock clause for trenching and boring
- Customer is tax exempt
- The existing conduit for Pernoshal to Brookrun is in place, free and clear of any obstructions

- Engineered surveying or drawings
- Costs for independent inspections or testing
- Union labor, escorts, specific wage rates, or certified payroll
- Permit
- Items that are not specifically listed in this quote are not included
- Network connectivity from each location
- LPR cameras, software, and camera license
- All work will be done during normal business hours
- Space will be available in existing (rack and/or cabinet) for new equipment
- No material will be ordered without approved submittals
- Manufactures and part numbers are subject to change due to availability and technology changes

6.0 Terms and Conditions

Terms and Conditions

- 1. **TAXES:** Prices exclude (unless otherwise noted in the proposal) all duties, taxes, tariffs, or other governmental charges that now are, or hereafter may be, imposed upon the sale or use of the Products or Services. All such duties, taxes, tariffs, or other charges paid by GC&E shall be for Purchaser's account. Any exemption claimed paid by GC&E shall be for Purchaser's account. Any exemption claimed from the application of such duties, taxes, tariffs, or other charges should be plainly designated on the face of orders placed with GC&E and accompanied by exemption certificates where required.
- 2. PRICE VALIDITY: The prices set forth in this proposal are predicated on receipt of a contract or Purchase Order within 30 days from the date of this proposal. If 30 days have passed and performance is required, GC&E reserves the right to revise the pricing in this proposal to reflect current material and labor market prices and current site conditions.
- 3. **PURCHASER SPECIFICATIONS:** GC&E Systems Group assumes no liability for any errors or omissions in any specification provided by the purchaser, including any errors or omissions made by GC&E in the interpretation of any such specifications. Any items included in any specification provided by the purchaser and not listed and priced on GC&E's proposal are not part of this Agreement.
- 4. LIQUIDATED DAMAGES: GC&E will not be responsible for any liquidated damages other than those attributed to delays caused solely by GC&E. If GC&E is one of several contractors responsible for delays, GC&E will only be responsible for a pro rata share of liquidated damages to the extent attributable to or cause by GC&E. GC&E will not be responsible for any liquidated damages in an amount greater than that actually accessed against GC&E.
- 5. **CANCELLATION:** This Agreement cannot be cancelled or postponed by the Purchaser except with GC&E's consent and upon terms that will indemnify GC&E against loss. Accordingly, Purchaser shall pay GC&E the greater of (i) a charge equal to 10% of its total price or (ii) reasonable cancellation charges, GC&E's anticipated profit, restocking fees, and expenses already incurred by GC&E in performing or preparing to perform the work required by Purchaser's order, as invoiced by GC&E. GC&E Systems Group reserves the right to cancel this Quotation Agreement if excessive downtime is encountered which, in the discretion of GC&E, is beyond its control (limited access to work area, training, etc.) or if customer fails to comply with any term of this agreement. The GC&E billable rate for downtime is per GC&E standard rates.
- 6. **INSPECTION:** Within five business days of receipt of the Products and Services, Purchaser shall inspect the Products and Services to check for shortages or any other nonconformity. Unless Purchaser shall thereafter notify GC&E in writing of any nonconformity (other than that relating to loss or damage in transit, which claims will be made directly to the carrier) within ten days of inspection, Purchaser shall be deemed to have accepted the Products and Services without any qualifications and cannot, thereafter, reject the Products and Services for any reason. In any event, Products and Services accepted and used shall be deemed to have been accepted in good condition and in compliance with the specification and order therefore.
- 7. **GOVERNING LAW:** The terms of this quotation shall be governed and interpreted in accordance with the laws of the State of Georgia. If any provision of this Quotation Agreement shall be held by a court of competent jurisdiction to be contrary to law, the remaining provisions shall remain in full force and effect.
- 8. **EXISTING CODE VIOLATIONS:** Existing code violations requiring correction by the local authority inspectors is the responsibility of the customer and is not included in GC&E's pricing.
- 9. PAYMENTS: Payment is due Net 30.
- 10. **DELINQUENT PAYMENTS:** If any amount owning to GC&E under the terms hereof is not paid when due, interest shall accrue on any unpaid balance at a rate of 1.5% (1% for Georgia customers per O.C.G.A. § 13-11-2) simple interest every thirty (30) days. Additionally, in the event full payment is not made and GC&E is required to institute legal proceeding in order to collect amounts owing hereunder, the party against whom enforcement is sought shall be required to reimburse GC&E for all reasonable costs of collection, including attorneys' fees, if GC&E is ultimately successful in prosecuting its claims.
- 11. **DISCLAIMER:** In no event shall GC&E Systems Group be responsible for any direct, incidental, special or consequential damages, including loss of profits, revenue, and/or data, incurred by any party to the agreement, or any third party, resulting from the usage of products or services supplied under this Quotation Agreement, even if such party has been advised of the possibilities of such damages.

ACCEPTED: This Quotation Agreement and any exhibits attached hereto constitutes the entire agreement between parties concerning the subject matter hereof, superseding all prior negotiations, discussions and agreements, oral or written. 


Design Tool for AXIS Perimeter Defender




Pernoshal Trail to Brook Run


