**A RESOLUTION TO APPOINT MEMBERS OF THE SUSTAINABILITY  
COMMITTEE FOR THE CITY OF DUNWOODY, GEORGIA**

**WHEREAS,** the City of Dunwoody is authorized by the City Charter to create boards, commissions and authorities as the Mayor and City Council deem necessary; and

**WHEREAS,** Resolution 2008-12-31 created the Sustainability Committee (formerly known as the Sustainability Commission) for the City of Dunwoody, GA; and

**WHEREAS,** Ronald Davis, Debbie Gordon, and Debi Shendelman were previously appointed as members of the Sustainability Committee to a three year term of office expiring on December 31, 2020; and

**WHEREAS,** the Mayor and City Council now wish to appoint Fikrat Atalay, Ronald Davis, and Debi Shendelman as members of the Sustainability Committee with a three year term of office for each member as follows:

Fikrat Atalay, 3 year term .....expiring December 31, 2023  
Ronald Davis, 3 year term.....expiring December 31, 2023

**WHEREAS,** Resolution 2016-03-06 revised the membership of the Sustainability Committee to add two ex-officio members who are high school students who are residents of the City of Dunwoody at the time of appointment and for the duration of the term to serve a 2-year term, and two ex-officio members who are college students who are residents of the City of Dunwoody at the time of appointment and for the duration of the term to serve a 2-year term; and

**WHEREAS,** the Mayor of the City of Dunwoody is authorized with confirmation from the City Council to appoint I as one of two high school students to be appointed as a members of the Sustainability Committee for the City of Dunwoody with the following term of office:

Avery Watts, 2 year term .....expiring upon high school graduation

**WHEREAS,** this Resolution shall become effective upon its adoption.
