Subject: Resolution Authorizing Elected Officials of the City of Dunwoody to be Covered under the Georgia Municipal Association Workers' Compensation Self-Insurance Fund

BACKGROUND

Georgia Municipal Association requires a resolution for the City's elected officials to be covered under the Georgia Municipal Association Workers' Compensation Self-Insurance Fund.

FISCAL IMPACT

Coverage for the City's elected officials was included in the premium approved by Council in the November 30, 2020 Council Meeting. The GMA plan does not automatically include Council Members, so the resolution is needed. There will not be any additional premium charge as a result of the resolution.

RECOMMENDED ACTION

It is respectfully requested that Council approve the resolution for the City's elected officials to be covered under the Georgia Municipal Association Workers' Compensation Self-Insurance Fund.

- 2) The Mayor of the City of Dunwoody is hereby authorized to execute any and all documents necessary to enroll the City of Dunwoody elected officials for coverage in the Georgia Municipal Association Workers' Compensation Self-Insurance Fund.
