Subject: ARC Community Development Assistance Program

BACKGROUND

ARC's Community Development Assistance Program (CDAP) provides planning assistance to local governments, CIDs, and non-profits across the 10-county metropolitan region to undertake local planning activities that advance the goals of the Atlanta Region's Plan.

The City of Dunwoody is jointly applying with the Perimeter CID for CDAP to assist the Economic Development and Community Development Departments in creating a Blueprint for future economic growth in the Perimeter Dunwoody Market. This assistance will include technical analysis of Existing Conditions in the market and a Strategic Stakeholder Conversation that will develop a vision for growth over the coming decades.

The CDAP Application requires a Resolution of support from program participants. We are not requesting funding from the City, the Dunwoody Development Authority and Perimeter CID have committed to split any matching funds that may be required for the Program.

The Application is due February 26, 2021 with an early Summer Selection. If selected, the Program would commence in the Fall with a May 2022 completion.

RECOMMENDED ACTION

Staff respectfully requests Mayor and Council Approve the Resolution of Support for ARC's Community Development Assistance Program.
