Subject: Funding Authorization for 2572 Briers North Drive Stormwater Repairs

ITEM DESCRIPTION

Approval of Funding for Stormwater Repairs at 2572 Briers North Drive. Estimated cost, plus 20% contingency, is \$65,316.90.

BACKGROUND

Structural deficiencies to the storm system on Briers North Drive were identified responding to a sinkhole on 3/29/2021. The entire pipe system is composed of 36-inch corrugated metal pipe that is approximately 34.4 years old and in poor condition. CCTV footage discovered corrosion with visible holes in the pipe. Recommended repairs include:

- Repair 160 LF of " Corrugated Metal Pipe (CMP) with EcoCastTM geopolymer
- Invert repair with flowable fill
- Sinkhole Repair

If approved, this project will be funded from the FY2021 Stormwater Repairs and Maintenance Budget.

RECOMMENDED ACTION


Staff recommends approving \$65,316.90 in funding for Stormwater Pipe Repairs at 2572 Briers North Drive.




