Subject: Resolution to Set Permit Fees for Ancillary Tastings of Distilled Spirits

ITEM DESCRIPTION

This item is a set fees for ancillary tastings of distilled spirits. The annual fee would be \$400 annual fee and the daily fee would be \$50. A corresponding ordinance creates regulations for ancillary tasting permits for distilled spirits.

DISCUSSION

The City of Dunwoody currently sets fees of \$300 for an annual ancillary tasting permit for beer and \$300 for an annual ancillary tasting permit for wine. Alternatively, an eligible business may obtain a per-day permit, which has a fee of \$50 for either beer or wine. The proposed fees are in line with the current fees and the City's custom of charging higher fees for distilled spirits compared to beer and wine.

STAFF RECOMMENDATION

A RESOLUTION TO SET FEES FOR ANCILLARY TASTINGS OF DISTILLED **SPIRITS**

- WHEREAS, the Charter of the City of Dunwoody authorizes the City to provide for the general health, safety, and welfare of the citizens of the City; and
- WHEREAS, the Charter of the City of Dunwoody further authorizes the City to issue licenses for sale and pouring of alcoholic beverages, as well as collect all appropriate fees and taxes; and
- WHEREAS, the Mayor and Council of the City of Dunwoody on June 14, 2021 set standards for ancillary tastings of distilled spirits; and
- WHEREAS, the City does not currently have any fees for said ancillary tastings of distilled spirits and the Council finds that fees of \$400 for an annual ancillary tasting permit for distilled spirits and \$50 for a daily ancillary tasting permit for distilled spirits are reasonably related to the cost of the City in regulating said permitting.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DUNWOODY, as follows:

Section 1. That the schedule of fees for alcohol licenses is hereby amended to include the additional fees of \$400.00 for annual ancillary tasting permits for distilled spirits and \$50 for daily ancillary tasting permits for distilled spirits; and

Section 2. That the staff is hereby authorized and directed to implement the amended schedule of fees herein.
