Subject: Not for Profit Grant Amendment Revision

Mayor and Council originally appropriated \$400,000 to eight not-for-profits using CARES II funding. As each agency expends \$50,000, staff is bringing forward a contract amendment to allow that figure to increase to \$75,000 and be used for the continuation of any of their programs serving the local community.

Malachi's Kitchen has now expended \$50,000 and staff recommends an increase to the contract of \$25,000.
