State Certification is neither easy, nor simple. In fact, achieving State Certification requires a great deal of effort and commitment to a complex task, which requires compliance with a solid and complete set of policies that cover all the areas found in the standards.

Certification standards focus on officer safety and high liability issues; however, the certification process goes far beyond just these important issues by offering proof to your community that you are doing the right things for the right reasons. Certification standards are indeed a blueprint for success in the field of law enforcement.

The State Certification standards are continuously under review. This is reflected by the fact that the program is currently under Edition 6.1 of the Certification Standards. Recently, there were several modifications made to keep the State Certification Standards up to date with the current legal issues in law enforcement. There is little doubt that law enforcement is under a microscope nationwide. Certification is more relevant today than ever before.

In 2006, the GACP partnered with the Georgia Interlocal Risk Management Agency (GIRMA) to provide special rate reduction incentives to cities and counties that have achieved and maintained their State Certification status. These rate reductions can decrease liability premiums by up to 20 percent. In addition, GIRMA contracted with the Legal and Liability Risk Management Institute to
