<u>A RESOLUTION APPOINTING MEMBERS OF THE URBAN REDEVELOPMENT</u> <u>AGENCY OF THE CITY OF DUNWOODY</u>

- WHEREAS, Chapter 61 of Title 36 of the Official Code of Georgia Annotated ("O.C.G.A."), entitled the "Urban Redevelopment Law," as amended (the "Urban Redevelopment Law"), creates in each municipality in the State of Georgia a public body corporate and politic to be known as the "urban redevelopment agency" of the municipality, for the purpose of exercising the "urban redevelopment project powers" defined in Section 36-61-17 (b) of the Official Code of Georgia Annotated; and
- **WHEREAS,** by Resolution 2012-04-13, the Mayor and City Council activated the Urban Redevelopment Agency of the City of Dunwoody; and
- WHEREAS, the City of Dunwoody is authorized by the City Charter to create boards, commissions and authorities as the Mayor and City Council deem necessary; and
- WHEREAS, the Mayor and City Council previously adopted Chapter 2 ("Administration") of the City Code of Ordinances which provides for the appointment of a member to replace an outgoing member of any City Board; and
- WHEREAS, the Mayor and City Council previously appointed Ken Wright as a member of the Urban Redevelopment agency of the City of Dunwoody, whose term of office has become vacant prior to the end of his term; and
- **WHEREAS,** the Mayor and City Council previously appointed Rob Augustine, Robyn Files, Summey Orr, Samyukth Shenbaga, and Ken Wright as members of the Urban Redevelopment Agency of the City of Dunwoody; and
- **WHEREAS,** the Mayor of the City of Dunwoody is authorized with confirmation from the City Council to appoint the following persons as members of the Urban Redevelopment Agency of the City of Dunwoody with the following term of office:

Rob Augustine, 3-year term	expiring June 30, 2028
Robert Buckey, filling unexpired 3-year term	.expiring June 30, 2026
Robyn Files, 3-year term	expiring June 30, 2028
Summey Orr, 3-year term	.expiring June 30, 2028
Samyukth Shenbaga, 3-year term	expiring June 30, 2028.

WHEREAS, this Resolution shall become effective upon its adoption.

NOW THEREFORE BE IT RESOLVED AND EFFECTIVE by the Mayor and Council of the City of Dunwoody while in regular session on June 16, 2025 at 6:00 pm that Rob Augustine, Robert Buckey, Robyn Files, Summey Orr, and Samyukth Shenbaga are appointed as members of the Urban Redevelopment Agency of the City of Dunwoody for the designated terms.
