



Reporting Code Violations

Code violations can now be reported online to help citizens and the City of Dunwoody staff connect more quickly and efficiently. When a request is submitted, an automated email is sent to city personnel. The request will then be evaluated and can be turned into a Code Enforcement case, if necessary. The status of the request can be updated by city staff and viewed by the individual who submitted the request.

There are two ways to submit requests:

- 1. Go to: dunwoodyga.gov/codeviolation
- or download the mobile app "iWorQ Service Request" and use the Agency Code of Dunwoody.



- Apartment Sweeps
- Prohibited signs
- Commercial Property Sweeps
- Short-term Rental Enforcement



Apartment Sweep Program

- Inspections are done on multi-family units.
- Only exterior violations are noted.
- Property management is given an inspection report.
- Most cases 30 days to comply.



Apartment Sweep Program











Prohibited Signs







Vacant Properties

- Vacant property list is maintained
- Each property is inspected once a month.
- Properties are taken off list after purchase
- Critical inspections





Short-term Rental Enforcement

- Properties or Units are identified via citizen complaint, or rental website
- Once property owner is confirmed and identified a notice of violation is issued
- Property Owners are given a compliance date to bring any listed short term rentals in compliance.
 Compliance meaning listing is available for lease of 30 days or more.



Short-term Rental Enforcement

- Working closely with leasing offices to identify units within multi-family properties.
- Challenges identifying persons with listings in multifamily units.
- Challenges in monitoring different platforms that list rentals.
- Education is working with single family rentals.
