Major Projects:

- The fire line backflow repair and replacement completed at City Hall.
- Pics in the Park and Groovin' on the Green Series kicked off summer with large crowds.
- The Park Maintenance contract is out to bid, and responses are due July 20th.
- The Dunwoody Cultural Arts Center/Spruill Expansion is progressing well. Contractor has completed foundation work and block walls are being installed.
- The staff met with the Stormwater staff and members of the Dunwoody Nature Center for the pre-construction meeting of the drainage infrastructure improvements at the Eco-Classroom. The work is expected to begin mid-July.

Other Highlights:

- The new partner program with First Baptist Church, ready for August 1st registration. The program offers basketball leagues for U6 to adults, beginning November 11th.
- The sister sculpture to Grounded Growth at Brook Run Park is in progress. The 15-foot sculpture features seating for 16 along flower petal benches and installation is tentative for Fall 2023.



• July is Parks and Recreation Month and will be highlighted with staff interviews posted on social media throughout the month.

Workload/Activities:

- The staff is working on the surface drainage mitigation at the Donaldson Bannister Farm, including regrading and installation of plant material.
- StoryWalk and Little Free Libraries are being inspected by seasonal staff for damage and book needs. The staff will coordinate with the Friends of the Dunwoody Library for replenishing books at the Little Free Libraries.

PUBLIC WORKS

Upcoming Events: (July-September 2023)

- Public comment period for sidewalk concept designs on Happy Hollow Road, Chamblee Dunwoody Road at Oakpointe Place, Dunwoody Club Drive, Perimeter Center East, Peeler Road at Equestrian Way and Happy Hollow Road
- Stormwater pipe rehabilitation on Wyntercreek Court, Devonshire Way and Lakeside Drive.

Major Projects:

- Dunwoody Road Sidewalk- Sol Construction has completed the retaining walls
 - and 90% of the curb. The stormwater pipe under the road was lined this month. Dunwoody Road will remain closed through the summer.
- Chamblee Dunwoody at Womack
 Intersection- Wilson Construction
 completed the base layer of paving on
 Womack Road. Final paving is expected
 later this summer. The granite facing on
 the retaining wall adjacent to the library is
 nearing completion so that artists can begin

work on the tile mosaic. The wiring for the new traffic signal is being installed. Minor traffic delays will occur on weekdays between 9 a.m. and 4 p.m.



- 2023 Pavement Resurfacing- <u>Blount resumed paving and completed the last segment of paving on Spalding Drive. Paving in the Renfroe Lake subdivision is planned for July.</u>
- Georgetown Gateway- AT&T installed new anchor poles. The city's contractor completed 330 feet of curb in the vicinity of Dunwoody Park. At the south end of the project the contractor completed 20 feet of stormwater pipe and installed 1 drainage structures. The pipe crew is having to work slowly to avoid the numerous utilities in the path of the pipe. The right, southbound lane at I-285 remains closed for pipe work. Minor traffic delays will continue on Chamblee Dunwoody Road.
- Vermack Road Path Phase I- <u>Autaco began work Vermack Path adjacent to</u> <u>Dunwoody High School.</u> Several underground utilities were relocated, and the northern section of the path will be constructed in July.
- Winters Chapel Trail, Phase I The contractor is expected to complete the punch list in July.

Other Highlights:

- The ARPA-funded Stormwater Construction Manager has facilitated the rehabilitation of over 1-mile of stormwater pipe in the past year.
- The Stormwater Management Plan for 2022-2027 has been submitted to the Georgia Environmental Protection Division for review.

Activities:

• The department completed 44 stormwater, roadway, and signal work orders.

COMMUNITY DEVELOPMENT

Recent and Upcoming Cases: (June 2023 – July 2023)

- June 1st: The Zoning Board of Appeals approved two residential variance requests and a parking variance for the Burger King on Chamblee Dunwoody Road
- June 13th: The Planning Commission recommended approval on two text amendments for drug rehabilitation centers and for medical cannabis dispensaries. There won't be a Planning Commission meeting in July.
- June 29th: The City Council had a first read for a rezoning and special land use permit for a new storage facility at 4470 Chamblee Dunwoody Road and a first read for the removal of conditions for 84 Perimeter Center East. The City Council



- also passed four text amendments and the special land use permit for the Marcus Jewish Community Center
- July 6th: The Zoning Board of Appeals will hear three residential variance cases.
- July 10th: The City Council will hear the two text amendment cases regarding drug rehabilitation centers and medical cannabis dispensaries in addition to the second read for 4470 Chamblee Dunwoody Road and 84 Perimeter Center East.

Major Projects:

- The Hall at Ashford Lane food hall is open.
- The work is continuing at Campus 244 with footings going in for the planned Element Hotel
- The 2023 Household Electronics Recycling Event is scheduled for October 1st at St. Luke's Presbyterian Church.
- The department has started accepting applications for the 2023 front yard trees program.

- The staff completed 46 erosion control inspections, with four notices of violation issued.
- The Code Enforcement division conducted 169 inspections, received 58 new complaints, and brought 33 cases into compliance.
- The Code Enforcement division removed 237 signs from the right-of-way.
- The staff issued 44 code enforcement warnings and 3 citations.
- The department received 139 permit applications and issued 111 permits.
- The department completed 490 building inspections.

- Officers responded to a report of a Stolen Auto. Officers checked Flock and were able to locate the vehicle at Asbury Square apartments.
- Officers responded to a Domestic Violence where a gun was possibly pulled on one party. As Officers approached the building, they heard potential gunfire.
 Offices were unable to locate evidence of shots being fired and both parties denied any gunfire.

 victim was sharing a room with a female friend. The victim passed out, and
 when he woke up, the female had stolen his vehicle. The vehicle was later
 located, and the suspect was arrested.
- Officers responded to a Suicide call at the Marriott Hotel. The victim apparently jumped from the 17th floor and was found deceased.
