#### MEMORANDUM

Subject:	Funding Authorization for Vermack Path at Dunwoody High School Phase I Construction

#### ACTION

Authorize the Mayor, City Manager, or designee to expend up to \$420,000, including a 10% contingency, from the SPLOST Project SP1-1821 budget for Autaco Development to build Phase 1 of the Vermack Road Path adjacent to Dunwoody High School.

#### SUMMARY

A 12-foot wide shared-use path is proposed to replace the existing sidewalk between Womack Road and Vanderlyn Drive adjacent to the high school. To minimize the impact on school operations the construction is being planned to occur in phases over the next two summers. This funding request is for Autaco Development to construct Phase 1 of the path this summer utilizing unit prices in their current standby construction contract with the city. Phase 1 extends from the southernmost school entrance to Vanderlyin Drive.

#### DETAILS

The SPLOST capital budget includes funding to replace the sidewalk on Vermack Road adjacent to Dunwoody High School with a shared-use path. The existing 5-foot-wide sidewalk is relatively narrow considering the proximity to the school and in several locations electric transmission poles reduce the sidewalk width to a point that it does not comply with requirements of the Americans with Disabilities Act. The conceptual plan for a 12-foot wide, shared-use path was presented for public comment in the fall of 2021 and discussed by the City Council in January of 2022. The project has also been presented to the Principal Advisory Committee at the high school and is included in the draft trail master plan.

The final design for the path has been completed and the right of way and easements needed to construct the path have been approved by the DeKalb County School Board. The design includes 500 feet of large diameter pipe to store stormwater runoff and utility relocations that would make it challenging to complete all of the improvements in one summer. As a result, the construction has been divided into two phases with the first phase, from the southernmost school driveway to Vanderlyn Drive, planned for this summer. The second phase will include the stormwater pipe which is being redesigned to avoid a power transmission pole.

The proposed funding authorization of \$420,000 is for Autaco Development to complete Phase 1 utilizing unit prices in their current standby construction contract. The second phase of the

construction, scheduled for the summer of 2024, would be procured separately in early 2024. The city's SPLOST project budget includes \$800,000 in project SP1-1821 for construction.

#### **RECOMMENDED ACTION**

Authorize the Mayor, City Manager, or designee to expend up to \$420,000 from the SPLOST Project SP1-1821 budget for Autaco Development to build Phase 1 of the Vermack Road Path adjacent to Dunwoody High School.


