**Subject:** **Approval of a Lighting Services Agreement with Georgia Power for Lighting on Meadow Lane Road and Crown Pointe Parkway**

### **ACTION**

Authorize the Mayor, City Manager, or designee to execute a lighting services agreement with Georgia Power to install and maintain lighting on Meadow Lane Road and Crown Pointe Parkway.

### **SUMMARY**

Most of Meadow Lane Road and Crown Pointe Parkway are currently unlit and the city has received several requests from the public to improve the visibility. The city has worked with Georgia Power to develop a lighting plan for the corridor that includes 16 double head roadway lights installed in the median and 8 post top mounted lights at crosswalks on the north side of the road where the highest pedestrian traffic occurs. The style of the lights will be the PCID standard and the PCID will contribute half of the installation cost.

The proposed lighting services agreement between the city and Georgia Power includes an installation cost of \$293,800 and an ongoing monthly cost of \$1,160 for maintenance and energy costs. There is funding designated in the APRA II fund for Public Safety/Lighting that can be used for the city's half of the installation cost. The monthly cost will be added to the city's commercial streetlight special assessment district.

### **RECOMMENDED ACTION**

Authorize the Mayor, City Manager, or designee to execute a lighting services agreement with Georgia Power to install and maintain pedestrian lighting on Meadow Lane Road and Crown Pointe Parkway.

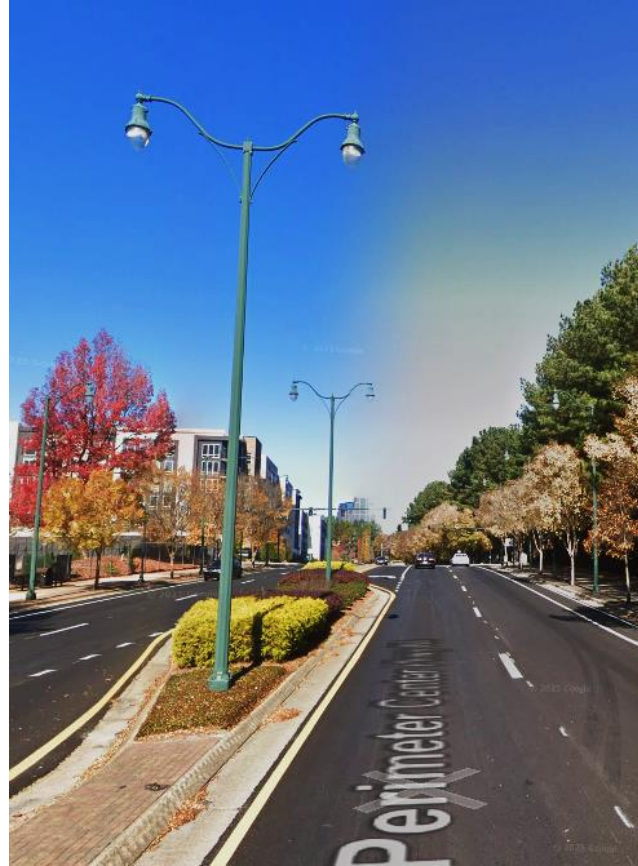

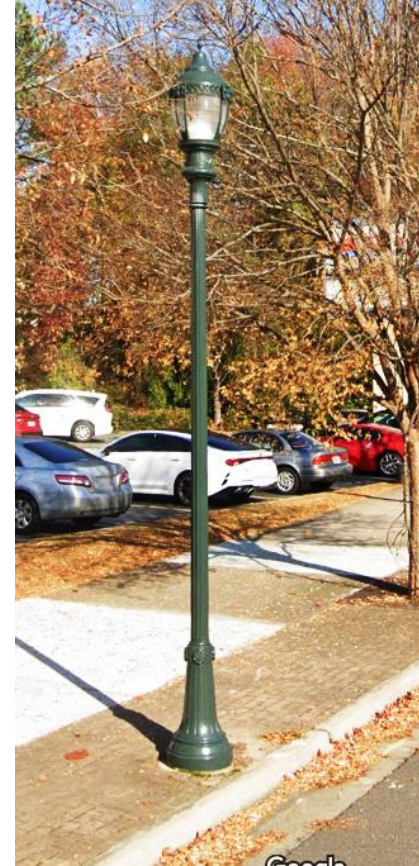
