

City Manager Monthly Report Report Ending February 7, 2025



PARKS

Highlights:

- New stargazing program at Homecoming Park launches February 12th, facilitated by Atlanta Astronomy Club. 26 participants have already registered.
- Two Bridges Park art sculpture complete and open to the public. The sculpture welcomes groups and individuals to interact with the piece and take pictures. Ribbon cutting to be scheduled in the coming weeks.

Accolades and Happenings:

• Dunwoody Senior Baseball and Spruill Center for the Arts will celebrate 50th anniversaries and Lemonade Days will host their 25th annual festival in 2025.

Department Items:

- Winter-Spring '25 L.E.A.F. was released. Guide focuses on new and recurring programming and special events for January-April, across the city.
- MLK, Jr. Day of Service postponed to February 1 due to extreme cold. Projects will still include tree and daffodil plantings at Brook Run Park, cleanup of the Brook Run Community Garden, and blood donations through LifeSouth.

Data:

- Dunwoody Preservation Trust opened registration to Camp Flashback on January 21st. In less than 10 days, more than 160 children were signed up for summer camp.
- *Every Christmas Story Ever Told* welcomed over 900 attendees across 10 performances.



POLICE

Highlights, Accolades and Happenings:

- Mayor Deutsch presented the Oath of Office to three new officers and one new sergeant at the January 13, 2025, Council meeting.
- During Winter Storm Cora, the newly acquired Real Time Crime Center (RTCC) once again proved to be an invaluable tool as technicians were able to monitor safety conditions throughout the City and field a solid emergency response in conjunction with Public Works staff.
- Thanks to donations from the Dunwoody Police Foundation, we were able to purchase a multi-purpose kennel for Hank, 2nd K-9.

Workload/Activities (highlights):

- Theft Ashford Dunwoody Rd: The owner of a concrete company discovered his 14ft dump trailer and Skid Steer missing from the worksite at 10:30am.
- Motor Vehicle Theft Peachford Rd: Victim called about someone attempting to steal his Kia Sportage. Victim believes that it occurred overnight. There was damage to the steering column
- Vehicle Crash w/Injuries / T.R.I.P. Activation I-285 east bound at Ashford Dunwoody Road: An 18-wheeler traveling eastbound in lane 2 attempted to merge into lane 3, colliding with another vehicle. The impact caused the other vehicle to spin out. The 18-wheeler overcorrected, striking the median wall and becoming disabled in lane 1. While enroute to the initial crash and merging into traffic, a HERO unit was involved in a secondary collision. GSP responded to investigate this separate crash. The driver of the 18-wheeler was cited for trucks over 6 wheels in prohibited lanes, and improper lane change. Three left lanes were closed for approximately 2 hours while T.R.I.P. worked to remove the truck.
- Fraud Luray Dr: The victim reported being scammed after meeting two individuals while incarcerated, one in person and another by phone. After sending small payments previously, the victim received a text on 01/21/25, about a missed \$2,800 bond payment. The phone contact offered to cover most of the payment if the victim sent \$400 via Cash App. After sending the money, the victim discovered the bond notice was fraudulent.
- Pickpocketing Ashford Dunwoody Rd: The victim reported her wallet stolen from her purse at approximately 4:30pm. A review of the surveillance footage showed the victim being followed by a female suspect, who is then observed taking the victim's wallet from her purse before disappearing. The stolen wallet

was described as a Louis Vuitton valued at approximately \$1,300 and it contained multiple credit cards, as well as ID cards.

- Fraud Dunbar Dr: In early 2024, the victim booked a Costco cruise. On October 28, 2024, the "Trip Center" called and claimed to be Costco's third-party agent, and subsequently charged the victim's credit card \$3,232.50. Recently, Costco requested the same payment, revealing that the "Trip Center" was fraudulent as Costco has no third-party partners.
- Medical Call Perimeter Center West: Officers were dispatched to a medical call of a victim who did not have a pulse and was not breathing. Officers arrived and started CPR, and an AED was attached to the victim, and it gave one shock. Medical personnel arrived on scene and took over life saving measures. The victim regained a pulse and was transported to the hospital.

PUBLIC WORKS

Highlights:

• Nature Center Wetlands Restoration- Work began on the stream channel stabilization.

- Old Spring House Path bid advertisement delayed awaiting Georgia Power easement acquisition.
- Responded to winter storms on January 10th and January 21st. Approximately 7,000

gallons of brine applied to major roads prior to the storms.

• Cold temperatures for most of the month limited the ability to complete asphalt repairs. Maintenance activities were focused primarily on stormwater work.



• The city has received the Tree City USA designation for the 13th year in a row.
